d. Stations:

- (1) At beginning of period Company was stationed at LaMadeline, France, Q-965075.
- (2) On 2 Sept. Co. headquarters moved by motor convoy to Trilport, France, S-534498.
- (3) On 5 Sept. the Co. moved to La Capelle, France.
- (4) On 14 Sept. the Co. moved to Vierzet Barse, Belgium, remaining there through the end of the period.

e. Marches:

All travel between station locations (see par. d above) was accomplished by infiltration type motor marches. The Company made no marches as a complete unit during the period.

OPERATIONS DURING PERIOD

On the morning of the 1st of Sept. vehicles of the two Bridge Platoons returned from the town of Meulan, on the Seine River north of Paris, where equipment had been delivered for a floating bailey bridge which was constructed by the 234th Engr. C. Bn. The Light Equipage Platoon was engaged in transporting Engineer Supplies from the Army Engineer Dump at Alencon to the new dump at Senonches. Re-supply of Bailey Equipment necessitated a trip to Caen, France where replacement bridge was obtained from a British Dump. The total trip took five days.

On 2nd Sept. while the line platoons were engaged in the above operations, Company headquarters moved from La Madeline, through Paris to the vicinity of Trilport, just East of Meaux.

On the 4th of Sept. after delivering a load of Engineer Equipment to the new location of the Army Depot at Trilport, the Light Equipage Platoon returned to the Company's previous location near La Madeline, to pick up the platoon basic equipment.

On 5th Sept. a 336 foot Infantry Footbridge was delivered to the 1110th Engr. C. Group near Compiègne. No information regarding the construction or use of this bridge is known, since the equipment was simply unloaded on the ground at a spot designated by the Group requesting the equipment.

Company headquarters moved again on 6 Sept. 1944 to the vicinity of Buironfosse, near LaCapelle, France. The company location was selected for its proximity to the new location of the Army Engineer Dump at La Capelle.

The two bridge platoons completed clearing out a small bridge dump near Laon, and moving the equipment forward to the main Army Depot at La Capelle. Upon completion of this job on 9th Sept. the company, completely assembled, remained idle until the 11th Sept., when the bridge platoons were loaded with Floating Bailey Bridge and transported it to the new location of the Army Engineer Depot at Modave, Belgium.

Company headquarters and the Light Equipage Platoon moved on 14th Sept. to Vierzet-Barse, Belgium, near the new location of the Army Engineer Depot at Modave. The two Bridge Platoons continued to bring forward Engineer Equipment to the Army Depot at Modave, until 20 Sept. when they were returned to the Company loaded with Floating Bailey Bridge, and were held there in readiness.

No further operations were engaged in for the remainder of the period.
